Northeast Flat-Coated Retriever Club Members,



Our members ferried equipment, ammunition, popper guns, blinds, white shirts, radios and ribbons to the test from all corners of the Northeast while Yankee people pulled from their "closet" an array of tossers, popper gun holders, bird drier racks etc. I've often likened the process of putting on a hunt test as organizing a wedding, regardless of the weather. This year we had perfect weather for running dogs and a "country wedding" where all the friends and family brought the essentials!

We did the best we could considering the ground conditions- not sure there's much of any mowing going on at West Thompson anymore, plus the lake level was a high as I've never seen before- and we were glad to see so many dogs show us great hunting abilities and pass the test. All in all, it was a pleasure for me to be a part of this, and the day went by too quickly."

WC: We had 17 dogs entered, with 15 started, and 11 passed; Four FCRs and seven Golden Retrievers. WCX: We had 18 dogs entered, with 16 started, and 9 passed; Three FCRs and six Golden Retrievers.
